COURSE OUTCOMES

This qualification reflects the role of remedial massage therapists who work with clients presenting with soft tissue dysfunction, musculoskeletal imbalance or restrictions in range of motion (ROM). Practitioners may be self-employed or work within a larger health service.

To achieve this qualification, the candidate must have completed at least 200 hours of work as detailed in the Assessment Requirements of units of competency.

LICENCING REQUIREMENT

No occupational licensing, certification or specific legislative requirements apply to this qualification at the time of publication.

CAREER OPPERTUNITIES

Potential employment options is in the role of a remedial massage therapist in a range of industry areas, such as Assistant massage therapist, Massage therapist and Massage therapy practitioner.

Students who complete this course may wish to continue their education into the a range of Diploma or Advanced Diploma qualifications, as well as higher education qualifications in massage therapy.

THIRD PARTIES

PREREQUISITES

There are no prerequisites associated with this qualification. Individuals may enter HLT52015 Diploma of Remedial Massage with limited or no vocational experience and without a lower level qualification.

ENTRY REQUIREMENT

Domestic Students must:

1. be a minimum of 18 years of age
2. have completed Year 12 or equivalent and,

3. successfully completed the AIS pre-course review.

International Students must:

1. be a minimum of 18 years of age,
2. have completed Year 12 or equivalent,
3. Complete the AIS Pre-enrolment suitability form to determine suitability for the course and student needs,
4. Have an IELTS* score of 5.5 or equivalent (test results must be no more than 2 years old).

*Note that other English language tests such as PTE and TOEFL can be accepted. Students are required to provide their results so that it can be confirmed they are equivalent to IELTS 5.5.

RECOGNITION OF PRIOR LEARNING AND CREDIT TRANSFER

Students may apply for recognition of existing qualifications or skills, knowledge, and experience by either Credit Transfer (CT) or Recognition of Prior Learning (RPL). The granting of course credit may affect course fees as well as the duration of the course.

This process is outlined in Australasia International School Student Enrolment and Completion Policy and Associated Procedures and Training and Assessment Policy & Associated Procedures.

AWARD QUALIFICATION AND OUTCOME

DELIVERY MODE AND DURATION

- Time to complete: Up to 80 weeks
- Terms: 6 terms
- Each Term: 10 weeks plus a 2 week study break (an extra 4 weeks over the Christmas)
