The Australasia International School has professionally set up Beauty training rooms with highly skilled trainers to facilitate this course so that students can learn, be confident and ready for industry upon successful completion.

COURSE OUTCOMES & CAREER OPPORTUNITIES

This qualification reflects the role of individuals who work as beauty therapists to provide a range of beauty therapy treatments and services, including lash and brow treatments, nail services, make-up, massage, and waxing. They communicate with clients to recommend treatments and services and sell retail skin care and cosmetic products.

These individuals undertake work independently, with limited guidance from others, to perform routine and non-routine activities and solve non-routine problems. They apply and adapt technical skills and knowledge and use judgment in the provision of beauty treatments and services. These individuals are responsible for their own outputs and provide limited guidance to others.

Work is typically conducted in beauty salons and spas. The skills in this qualification must be applied in accordance with Commonwealth and State or Territory legislation, Australian standards and industry codes of practice.

No occupational licensing, certification or specific legislative requirements apply to this qualification at the time of publication.

STUDY PATHWAY

Students who complete this course may wish to continue their education into SHB50121 Diploma of Beauty Therapy and a range of other Advanced Diploma qualifications, as well as higher education qualifications in beauty therapy.

PRE-REQUISITES

There are no prerequisites associated with this qualification. Individuals may enter after SHB40121 Certificate IV in Beauty Therapy with limited or no vocational experience and without a lower level qualification.

ENTRY REQUIREMENT

Domestic Students must:

1. be a minimum of 18 years of age
2. have completed Year 12 or equivalent and,
3. successfully completed the AIS pre-course review.

International Students must:

1. be a minimum of 18 years of age,
2. have completed Year 12 or equivalent,
3. Complete the AIS Pre-enrolment suitability form to determine suitability for the course and student needs,
4. Have an IELTS* score of 5.5 or equivalent (test results must be no more than 2 years old).

*Note that other English language tests such as PTE and TOEFL can be accepted. Students are required to provide their results so that it can be confirmed they are equivalent to IELTS 5.5.

RECOGNITION OF PRIOR LEARNING AND CREDIT TRANSFER

Students may apply for recognition of existing qualifications or skills, knowledge, and experience by either Credit Transfer (CT) or Recognition of Prior Learning (RPL). The granting of course credit may affect course fees as well as the duration of the course.

COURSE CONTENT

The Certificate IV in Beauty Therapy requires the completion of 23 units of competency including 18 core units and 5 electives.

DELIVERY MODE AND DURATION

- Time to complete: Up to 80 weeks.
- Terms: 6 terms
- Each Term: 10 weeks plus a 3-week study break
- Delivery: Classroom and practical face to face training is provided in a clinic.
- Days: 3 days per week, each day is 7 hours with breaks
- Self-paced learning: 5 hours per week
- Self-directed learning: 5 hours per week
- Mode of delivery: This program is delivered in the classroom. Practical face to face training is provided initially in the classroom setting and then into the Clinic to work on external paying clients to further develop treatment skills and complete observation assessments.

WEEKLY HOURS

Classroom, 3 days per week, 7 hours face to face each day and a half an hour for lunch each day. Self-paced learning/research is 5 hours per week and Self-directed is 5 hours per week.

CAMPUS CLINIC

All of the treatments performed by student onsite in a Campus Clinic. All students in Clinic are studying and under the supervision of a qualified trainer. The Campus Clinic has been designed to provide students with a working environment and prepare them to work in Sydney's finest Salons and Day Spa's.
