#### **SHB50121 DIPLOMA OF BEAUTY THERAPY**

The Australasia International School has professionally set up Beauty training rooms and has highly skilled trainers to facilitate this course so that students can learn, be confident and be ready for industry upon successful completion.

#### **COURSE OUTCOMES & CAREER OPPORTUNITIES**

This qualification reflects the role of individuals employed as beauty therapists to provide a broad range of beauty therapy treatments and services including facial treatments, body massage and treatments, hair removal, lash and brow treatments, nail and make-up services. This includes consultation with clients to provide beauty advice, recommend beauty treatments and services, and sell retail skincare and cosmetic products.

These individuals work relatively autonomously and are accountable for personal outputs. Their work involves the self-directed application of knowledge and skills with substantial depth in some areas where judgement is required in planning and selecting appropriate equipment, services and techniques.

Work is typically conducted in beauty salons and spas. The skills in this qualification must be applied in accordance with Commonwealth and State or Territory legislation, Australian standards and industry codes of practice. No occupational licensing, certification or specific legislative requirements apply to this qualification at the time of publication.

#### **PRE-REQUISITES**

There are no prerequisites associated with this qualification. Individuals may enter SHB50121 Diploma of beauty therapy with limited or no vocational experience and without a lower level qualification.

#### **ENTRY REQUIREMENT**

Domestic Students must:

1. be a minimum of 18 years of age
2. have completed Year 12 or equivalent and,
3. successfully completed the AIS pre-course review.

International Students must:

1. be a minimum of 18 years of age,
2. have completed Year 12 or equivalent,
3. Complete the AIS Pre-enrolment suitability form to determine suitability for the course and student needs,
4. Have an IELTS\* score of 5.5 or equivalent (test results must be no more than 2 years old).

\*Note that other English language tests such as PTE and TOEFL can be accepted. Students are required to provide their results so that it can be confirmed they are equivalent to IELTS 5.5.

#### **RECOGNITION OF PRIOR LEARNING AND CREDIT TRANSFER**

Students may apply for recognition of existing qualifications or skills, knowledge, and experience by either Credit Transfer (CT) or Recognition of Prior Learning (RPL). The granting of course credit may affect course fees as well as the duration of the course. This process is outlined in Australasia International School Student Enrolment and Completion Policy and Associated Procedures and Training and Assessment Policy & Associated Procedures.

## COURSE CONTENT

The Diploma of Beauty Therapy requires the completion of 29 units of competency including 20 core units and 9 electives.

## DELIVERY MODE AND DURATION

- Time to complete: Up to 104 weeks
- Terms: 8 terms
- Each Term: 10 weeks plus a 3-week study break
- Delivery: Classroom and practical face to face training is provided in a clinic.
- Days: 3 days per week, each day is 7 hours with breaks
- Self-paced learning: 5 hours per week
- Self-directed learning: 5 hours per week
- Mode of delivery: This program is delivered in the classroom. Practical face to face training is provided initially in the classroom setting and then into the Clinic to work on external paying clients to further develop treatment skills and complete observation assessments.

## CAMPUS CLINIC

All of the treatments performed by student onsite in a Campus Clinic. All students in Clinic are studying and under the supervision of a qualified trainer. The Campus Clinic has been designed to provide students with a working environment and prepare them to work in Sydney's finest Salons and Day Spa's.
